IMPORTANT POLICY FEATURES

1. The Fieldhouse LLC/U.S.S.S.A. registered basketball teams may purchase this insurance.
2. The Fieldhouse LLC/U.S.S.S.A. basketball insurance covers the play and practice of **any amateur basketball**.
3. Coverage begins the day after postmark on the envelope containing your application and check.
4. **New policy period: 8-16-06 to 8-15-07.**
5. All coverage expires on 8-16-2007.
6. Youth Insurance – \$100
Adult Insurance – \$250 Deductible
7. Coverage is secondary to any other collectible insurance; primary if no other insurance is in force.
8. The entire premium is earned upon policy issuance. There are no cancellation refunds.
9. Age of oldest child on date of purchase determines team age bracket.

FACILITY OWNER COVERAGE

If requested, your facility owner will be named as an additional insured at no additional charge. Liability coverage for the facility owner will be in effect during the play and practice of the insured team/league only. The limit of liability is \$2,000,000 per occurrence. Just complete the Facility Owner Section of the application and a certificate of insurance will be sent to verify coverage.

ACCIDENT MEDICAL EXPENSE BENEFIT

\$100,000 LIMIT

The plan pays for covered medical expenses incurred within one year after an accident, to a maximum of \$100,000 per accident for each insured person. Treatment must begin within 30 days of an accident.

Coverage is provided on a secondary basis. If other collectible insurance is in force, it must be used as primary. If no other coverage is in force, this coverage becomes primary.

The policy does not provide benefits for:

- a) treatment by family members or employees of U.S.S.S.A.
- b) hearing aids, vision correction, cosmetic surgery, experimental or investigational treatment, routine physicals, deviated nasal septum, routine foot care, counseling or psychiatric care; nor does the policy cover loss caused by, contributed to or resulting from:
 - c) sickness or disease;
 - d) suicide or attempted suicide or self-inflicted injury;
 - e) riding in any noncommercial aircraft or using a recreational vehicle or snowmobile;
 - f) participating in illegal activities or
 - g) being under the influence of alcohol or drugs.
